Meeting Minutes**

Meeting Date: 10 September 2019

Meeting Location - Heritage Bank Fayetteville, Georgia

- 1) The meeting was called to order at 7:10PM by President Don Bulloch. The Pledge of Allegiance and the Pledge to the SAR recited. The invocation was given by David Jessel. Ten (10) compatriots and 14 guests were present.
- 2) Don extended a welcome to all of the guests in attendance and asked the respective members to introduce their guests.
- 3) Award Presentation – David Jessel:
 - A) Charlie Hall – Deputy, Coweta County Sheriff's Department
 - B) Stacy Beckom – Deputy, Coweta County Sheriff's Department

Charlie received a call advising him that there were some cows loose and on the road. Charlie knew the owner of the cows. He contacted the owner and together they collected the animals and returned them to the pasture. The owner then started to go to the gate to secure it when he lost consciousness. Charlie called for an ambulance and started CPR on the victim. When Stacy arrived he continued CPR until EMS arrived. Had the cows not gotten loose, it is likely that the owner would have perished.

David presented both Deputies with the Life Saving Awards in recognition of saving a human life under emergency conditions.

Award Presentation – Don Bulloch

Don introduced Harrison Baro. Harrison is a Boy Scout who recently received the Eagle Scout award. He is a junior at McIntosh High School. In addition to academic honors and athletic participation he has initiated and successfully managed an internet business venture. After the school day he works at Chick-fil-A. This young man is an asset to his Community.

Don presented Harrison with a Certificate of Recognition for outstanding achievement and exceptional leadership and citizenship as evidenced by his attainment of the rank of Eagle Scout.

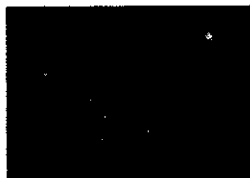
- 4) Don introduced the speakers for this evening, Brenda and David Jessel. The subject of the presentation was Our Alaskan Cruise and Wilderness Adventure 2019.

David along with his Wife attended the National Congress for the Sons of the American Revolution in California. As it was David's 80th birthday they planned and Alaskan

Cruise with extended sightseeing activity. In 2020 the National Congress will be in Richmond Virginia. The Following year the Congress will be held in Seattle Washington. A Cruise is being planned following that congress so start saving your pennies.

David's portion of the presentation included several pictures which proved to be interesting and educational. The rugged mountainous terrane of Alaska is evidenced in many of the pictures. His pictures also reflected the Russian influence on the development of Alaska. The sea portion of his tour ended with a close up view of a large glacier and a visit to Anchorage. They traveled by train to Fairbanks. "Our pictures do not show how beautiful it was." They got a car and visited the "North Pole."

Brenda's portion of the presentation focused Alaskan history. Alaska was a Russian colony from 1744 until 1867 when the U.S. purchased it for \$7,200,000.00. The Russian shops sell the Matryoshka, hand painted nested dolls.



The flag of Alaska consists of 8 gold stars forming the Big Dipper and Polaris on a dark blue field. The Big Dipper symbolizes the bear, an animal indigenous to Alaska. The alignment of the Big Dipper and Polaris as shown on the flag points the way to true north. The Alaskan flag is the result of a contest won by a 13 year old orphan, Benny Benson. Per Mr. Benson the blue field is for the Alaskan sky and the state flower, the Forget-Me-Not. The Northern Star is the future state of Alaska. The Dipper is for the great bear.

- 5) Following the presentation Don presented Brenda and David Jessel with a Certificate of Appreciation in recognition of outstanding support given to the Sons of the American Revolution, Marquis de Lafayette Chapter. Brenda was also given a FLAG.
- 6) Secretary's Report: Clark Perrin indicated that the August meeting minuets were completed and distributed. A motion was made, seconded, and passed to accept the minutes as written
- 7) Treasurer's Report: Vernon Bassham stated that the current checking account balance is \$3455.99. Vernon also advised the 2020 dues will be due soon. ***Welter added that our chapter gets points for every Compatriot paying dues before December 31.*** To accomplish this goal the checks should be in Vernon's hands no later than **Christmas Day.**

- 9) Historian Report: Dr. David Ludley reported that he is gathering various historic materials together.

- 11) Registrar Report: Michael Sanderson reported that he just turned over two (2) packets to the Genealogist for review. He further indicated that he has two (2) or three (3) others in the pipe line.
- 12) Sargent-at-Arms Report: Nothing to report
- 13) Americanism Committee Report: Nothing to report. Michael Sanderson mentioned that we should congratulate Bo Hill for his contribution in The SAR magazine (see page 29 for the article).
- 14) Boy Scout Committee Report: Harrison Baro came in this evening. Marc arranged this back in June. There is still one more individual from the group of three (3) McIntosh students who may come in.
- 15) CAR/DAR/SAR Report: Nothing to report
- 16) Grave Committee Report: (REF: June 11 Meeting Minutes) James Strickland indicated that they have everything that is needed to take care of the Tombstone at the Brown Family Cemetery. David mentioned that if we are going to mark a grave we need to have a ceremony. Walter mentioned that there are four (4) grave markings coming up.
- 17) Flag Committee: Dr. David Ludley indicated that he presented a flag certificate to a Vietnam veteran Master Sargent James Thore.
- 18) JROTC Committee: David Jessel advised that the Fayetteville Christmas Parade would be held December 7th.

David will contact all of the units and have them participate in the Enhanced Program (Outstanding Cadet Program).

The Air Force is now back on board and is accepting our medals.
- 19) Web Master Report: Banks Glover asked how many members carry SAR business cards and how many of the business cards have the web site on the cards. This is an opportunity to spread the word.
- 20) Discussion: Nearly all of the local schools have some sort of a program on Veterans Day. The DAR attends these programs. If you are a Veteran you should attend. We should do the same. This is a good opportunity to add to their program and do some good for ours. We can promote the CAR, DAR, and SAR at these outings.

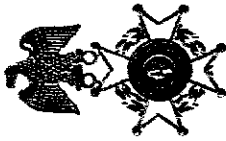

- 25) A motion was made and seconded and passes to adjourn. The SAR Recessional was recited, the Colors retired, and an Benediction given.
